### WORKING GROUP MEETING



S3 DEVELOPMENT MANUAL

Development Manual, The **S**3 developed within the framework of the CEDIS3 Project, will serve as the basis of the smart specialisation strategies to be developed in the three pilot regions. To achieve this, the first draft of the document was deliberated on during the Working Group meeting. Subsequently, it was disseminated among the members of the Working Group for further review. Aligning with the feedback received from the Working Group, efforts to finalise the document are ongoing.

The Second Working Group Meeting of the "Capacity Enhancement for Development and Implementation of Smart Specialisation Strategies in Türkiye's Regions (CEDIS3)" Project was held on 1 April 2024.

The meeting was chaired by the Head of the Department of Planning, Programming and Urban Development of the Ministry of Industry and Technology Ms Zeyneb Ersayın, and attended by experts from the Operation Coordination Unit, Ankara Development Agency, Ahiler Development Agency, West Mediterranean Development Agency, Eastern Anatolia Development Agency, as well as the Technical Assistance Team.

The meeting was attended online by Mr Dominique Foray to deliver his insights and opinions on the S3 Development Manual.

Focusing on the critical activities of the project, further planning of the training modules and the commencement of pilot activities were also discussed.
