OPENING EVENT

The Opening Event of "Capacity Enhancement for



Development and Implementation of Smart Specialisation Strategies in Türkiye's Regions (CEDIS3)" took place in Ankara, with the participation of the Deputy Minister of the Industry and Technology Prof Dr Ahmet Yozgatlıgil, Director General of the Development Agencies Mr Ahmet Şimşek, Director General of the EU and Foreign Affairs Mr Ahmet Halit Hatip and the Deputy Director General of the Development Agencies Mr Mustafa Işık; Head of Cooperation of the EU Delegation to Türkiye Mr Odoardo Como; Team Leader from the Joint Research Centre of the European Commission Mr Manuel Palazuelos Martinez as well as 176 participants from the development agencies and other stakeholders.



Implemented by DAI (in consortium with IPCEU and Tabu), aims to provide support to development of Smart Specialisation Strategies (S3) in the regions of Türkiye, in over 2 years with a budget of €2.6 million.

The CEDIS3 project will be a new milestone in the innovation-based sustainable growth journey of Türkiye and its regions by:

- Building and improving the capacity of the beneficiaries and other stakeholders
- Developing and implementing smart specialisation strategies in three pilot regions
- Strengthening the interregional cooperation and international partnership of all regions to develop S3, with a particular focus on the pilot regions

ADVISORY BOARD


The Advisory Board (AB) efforts have gained momentum and its general framework has been successfully established.
