#### MANUAL & ROADMAP

#### Within the purview of the Capacity Enhancement for Development and Implementation of Smart Specialisation Strategies in Türkiye's Regions (CEDIS3) Project, the S3 Development Manual has been matured through detailed reviews and contributions from experts.

Furthermore, the inaugural draft of the National S3 Roadmap has been formulated. ## **STUDY VISIT**
